

## Completion Rates of LCCW Doctor of Chiropractic students by gender, race and ethnicity

The normal duration of the standard Doctor of Chiropractic program at LCCW is 14 quarters. Completion rates are reported as the 150% Completion Rate (150CR), which is a statistic that captures the number of students who completed the DC program at LCCW within 21 quarters of the time that they started. Column 2 is the number of such completers of the program by the Completion Year indicated in Column 1. Column 3 is the number of matriculates entering 21 quarters prior to the Completion Year of Column 1.

For example, the result for the cohort year of 2015-2016 (77.3%) is computed from the number of non-transfer matriculates who started the program in SU10, FA10, WI11 and SP11 and who had completed the program by the end of SU15, FA15, WI16 and SP16.

<sup>1</sup>Non-Resident Alien category (Column 5) includes non-U.S. citizens (predominantly International students). These students do provide their ethnicities and race, and their demographic data are included in Columns 5-11. Thus, for reporting purposes, Column 4 includes both the number of graduates who are non-U.S. students *and* their percentage relative to the total number of graduates in that academic year.
